## INTRODUCTION

These Instructions cover the following models:

### PRODUCT

LFISD – Lateral Imaging Step

## INTENDED USE

The Rothband Imaging Step range has been designed for use during x-ray examinations of the lower limb.

As all Radiographers are aware, there are many variations in technique both departmentally and due to clinical situation and patient build. These recommendations are intended as a guide to enable a local protocol to be established and may be refined and adapted as and when required.

The Deluxe Lateral Foot Imaging Step includes a radiolucent zone in the foot plate that allows for clearance when applying caudal angulation.

## POSITIONING EXAMPLES



A closed cell foam Lateral foot block is provided with each step.

## TRANSPORTATION

The step is provided with wheels to facilitate its movement between examinations. Simply lift the end opposite the wheels until the step rides on the wheels for easy movement.

## CAUTIONS AND WARNINGS

- Intended for professional healthcare facility environments where operators with medical training are continually available when patients are present.
- Individuals embarking the step should be closely supervised and assisted.
- Individuals should not be left un-supervised whilst on the step.
- There are no special skills required to use this positioning aid.
- The step is only suitable for indoor use.
- The step should only be used on a flat and level surface.
- The medical professional is responsible for applying his/her best medical judgment when positioning a patient.
- The step is suitable for continuous use.
- Not suitable for sterilisation.
- Do not place device on or near a heat source.
- Do not use abrasive cleaners, please see relevant section for the correct cleaning instructions.
- The step should be regularly inspected for damage and loose fasteners.
- The above warnings, cautions and any safety considerations should be observed on a routine and regular basis, not only upon installation.
- The device has a weight limit of 150Kg

## CLEANING INSTRUCTIONS

Use a solution of mild soap or detergent or disinfectant\* in hand-hot water.

Apply using a soft cloth & light pressure to prevent swirls.

Rinse off with clean water and dry by blotting with a soft cloth/towel.

WSR Medical Solutions Limited recommend Envirolex hard surface cleaner.

\*DO NOT Use Solvents or Alcohol based cleaning products.

DO NOT Use any scouring materials/pads to clean the product as this will damage the surface finish.



Cross contamination is a major hazard to patients. The Imaging Steps should therefore be cleaned in between patients.
